### From meeting agenda:

- ULC update from Brian McBain, guest speaker. Brian gave a power point presentation of UL/ULC changes and clarifications. Brian will be forwarding information Robbin to distribute to the members from the power point presentation.

Can/ULC & ANSI standard changes in 2019. CAN/ULC-S1001 was revised in June 2019 Standard for Integrated Systems.

ULC will also be releasing a certification course for S1001.

Every ULC Standard is available for viewing online for free at: www.shopulstandards.com.

Brian talked about counterfeit UL/ULC products, such as extinguishers, sprinkler parts etc. All notices for counterfeit products can be found at UL Public notices website.

ULC cannot recall product, they can only inform the public. Health Canada or Manufacturer are the only bodies that can issue recalls. UL Product iQ to search all (worldwide) UL/ULC listed products.

Importers of equipment from other countries are responsible for bringing in properly listed ULC product. ULC is unable to police equipment being brought into Canada that has UL listing.

- Member annual association due invoices were sent by email/mail yesterday, January 30, 2020
- Financial yearend was sent to accountant on January 6, 2020. It was returned January 14, 2020. Robbin passed out copies to members for review. Any questions or concerns can be forwarded to info@albertafire.com
- ID cards for certified technicians. Details to move forward. Robbin presented possible liability issues with verifying credentials and maintaining the course recertifications, and specialized requirements within the NFC 19-AE. A discussion was held that if private companies wanted to create their own for their employees it would be a company liability. A motion was presented that the AFSA remove this item from the agenda from Darrell Shermak, Mike Williams seconded, approved.
- Qualified persons registry, options moving forward. It was suggested by Robbin that the same as above apply with the registry. Safety Codes Council has requested it remain on the Fire Sub Council agenda in hopes of moving forward. Shelby VanGroothest made the motion to remove this from the agenda, Ron Foxcroft seconded, approved.
   Ron presented the City of Calgary requirements for qualifications to perform service in Calgary; business id number, contractor's license, city qualified trades people. Pat Purnell added that the certification requirements by Intertek are very clear, but they rely on transparency and once the technician is outside the shop it is out of the certifying bodies capability to track competency or workmanship.
- Kevin Stanger advised that the mission statement from the old website was not moved to the new website. He would like to see it put back on the website for review at next meeting to determine if the purpose and goal of AFSA meet current compliance and industry needs. Robbin will ask Randy to add to web site.
- Kevin Stanger added the following items to the agenda;
- The bylaws be reviewed, updated and made public. Robbin has scanned the original documents. She will send a digital copy to Kevin Stanger via email (completed January 31, 2020). They will be retyped exactly, in order to have a digital copy. Once completed they will be distributed to the members via email and discussed at the next meeting.

#### **Committee Reports:**

- a. Portables: (Wayne Backiney): Wayne asked the group if there is anything AFSA needs Wayne to look into? Rusoh Inc fire extinguisher that does not require internal maintenance or hydro test. This is UL/ULC listed and can be sold in Canada. John Schmidt asked for clarification on what the Champion fire extinguisher is. Brian McBain stated that it is a ULC listed private label Kidde brand extinguisher being sold exclusively from Flame Tamer.
- **b. Fixed Systems:** (Ron Foxcroft): Ron Foxcroft said there are no updates at this time.
- c. Fire Alarms: (John Wingert): John Wingert was unable to attend. No other updates were given at this time.
- d. Canopy Cleaning: (Shelby VanGroothest): A US based training company is attempting to bring their training course into Canada. Shelby with AMA will be reviewing course material to see if it is viable in Canada..

- e. Fire Sub Council: (Robbin Foxcroft): The last meeting was held on January 23, 2020.
  - Micro distillery working group submitted recommendations for NBC/AFC/AEC to create Standata 'road map' for micro-distilleries. Cannabis extraction presentation. Federal government issuing medical cannabis growing licenses for residential homes for more than the legal 4 plants. Upwards of 200 plants for one person/residence. No wording in the federal requirement that these houses have to conform with any codes (NBC/NFC), regardless of amount of plants, or extraction process (chemicals). Maybe insurance statement or AMA documentation required. The Office of The Fire Commissioner has been disbanded. James Orr will hold the title of Fire Commissioner, whereas the inspectors will be reporting to Tina Parker.
- f. Fire Administrator's Office: (Tina Parker): Please send all future information requests to: safety.services@gov.ab.ca Attn: Fire Duty Officer. An application for non-post secondary portable fire extinguisher certification course that will be submitting a code change request for next cycle. Qualifications of Service Providers for Fire Protection equipment document to be released in the near future to clarify qualification requirements.
